1.0 Policy Purpose and Brief

Alliance Leisure develops facilities on behalf of leisure operators that want to improve or expand the leisure products and services they offer.

We recognise that all businesses impact on the environment in a variety of different ways. As such we are committed to the continual improvement of our environmental performance in relation to our services and operations.

We have identified the following key areas that we will focus on to reduce our impact on the environment:

- Our Culture Consumption of energy, water, paper and staff transportation
- Our Influence Impact of our supply chain partners
- Our Legacy Impact of our developments upon the environment

The company is committed to reducing these and other impacts whilst continuing to improve our environmental performance. To help achieve this, Alliance Leisure are working towards becoming a Carbon Literate Organisation and already hold Investors in the Environment Silver accreditation.

2.0 Our Culture

We are committed to working with our staff, customers, suppliers, investors, contractors, regulatory bodies, and neighbours to achieve the following objectives:

- Meet and where possible exceed all environmental regulations relevant to our organisation and its activities
- Reduce our consumption of energy and raw materials
- Reduce waste, pollution, and noise both locally and in the wider environment
- Systematically assess all aspects of our company for their environmental impact
- Set targets for measurable annual improvements
- Make our progress available for independent assessment
- Ensure supply chains have robust environmental protection strategies

The final layer of our policy looks at the legacy left by the leisure developments and project we deliver. To educate our clients using our Sustainability Toolkit around the various technologies and design adaptions that support reducing carbon emissions.

These priorities can sometimes clash or be at variance – it is our job to fully inform councils of the opportunities and options to deliver the best outcome for their communities and the environment.

Through our own culture, influence with our delivery partners and legacy in what we physically leave for councils and communities for generations to come, this can turn a seed of culture into a growth of sustainability.
